<sup>2</sup>*5-month payment options are charged on a valid credit card only on the first day of each month (2.01, 3.01, 4.01, 5.01 & 6.01), if the credit card does not go through for reasons beyond PSGC control, you will need to provide another card to replace it, if PSGC is unable to charge by the 3<sup>rd</sup> day after the payment is due, the membership may be cancelled and no refunds will be given for any prior charges. By signing above and providing the information herein you are agreeing to the total price, allowing PSGC to charge the listed credit card for the total price and the terms listed herein. Not available on Junior/High School Memberships. Payment plan balance due may be paid at anytime via credit card or cash. Payment plan is not available on cash discount option, may not be combined with a discount.*

*If a membership applicant signs up after the 2.01 initial payment date then the applicant's credit card will be charged the total amount that would have been collected starting on 2.01 to make payments current, as of the date of the application, then begin the 1<sup>st</sup> of the month payments to continue through the 6.01 last payment date. Example: Applicant signs up on March 15, applicant will be charged for Feb 01 and Mar 01 payments, then normal 1<sup>st</sup> of the month (4.01, 5.01 & 6.01) payments will begin for a total of 5 payments for the Anytime Price.*
