A. Notations

²*5-month payment options are charged on a valid credit card, provided by the applicant, on the date listed herein, or after that date if PSGC processing platform is in maintenance or other mode at that time. If the credit card does not process, for reasons beyond PSGC processing control, you will need to provide a valid credit card to process the payment. If PSGC is unable to process the charge by the 3rd day after the payment due date the membership may be cancelled and no refunds will be given for any prior charges. Not available on Junior/High School Memberships.*

By signing above and providing the information herein you are agreeing to the total price, noted as Anytime above, allowing PSGC to charge the listed credit card for the total price or 5-month payment option and the terms listed herein. 5-Month payment option balance due may be paid at anytime via credit card or cash. 5-Month payment option is not available on cash discount option and/or may not be combined with any other discount or promotion.

If a membership applicant signs up after the 2.15 initial payment date then the applicant's credit card will be charged the total amount that would have been collected starting on 2.15, catch-up payments, to make payments current as of the date of the application, then the 1st of the monthly payments begin on the 15th of each month until the final payment date on Jun 15. The payment option is NOT a finance plan but a 5-month payment option based on the standard membership rates. Anytime pricing is available at anytime and may be paid in full when signing up for membership.
