Annual Married Couple Full ("FC") - \$4,900 (marriage proof required)

Annual Single Full ("FS") - \$2,900

Annual Single Walking ("WS") - \$1,900 – (\$25 fee ½ cart, per round if using a cart)

Terms & Conditions

By applying, paying for and signing this Agreement you are attesting that all of the information herein is factual and accurate and agreeing to be bound by all terms and conditions herein to include: PSGC rules, regulations, property access and general terms and conditions posted on its web site or inside/around the club or as communicated by PSGC staff, and that any of these may be changed, deleted or added to at any time at the sole discretion of PSGC. You also agree that if you are claiming married status that you are legally married and have the supporting documents to support such (due to the discount associated with the couples membership rate you must submit your legal marriage certificate to PSGC to obtain this rate). Violation of any of PSGC's rules, regulations, property access and general terms and conditions may result, at PSGC's sole discretion, in the cancellation of your membership without refund.

Member assumes all costs, liability for accessing, utilizing or storing personal property on PSGC property and agrees to indemnify, assume all liability, release and hold harmless PSGC, its staff, Lessors, Lessees, affiliates, assigns, vendors, owners, members, partners, investors and guests from any and all liability, loss, damage, injury or other for any reason.

PSGC has the sole discretion and right without explanation or cause to approve, adjust, deny, amend, change, cancel, open, close, react to or address other needs relative to any aspect of its business needs to include: membership: types, offerings, availability, benefits, pricing, inclusions; restrictions related to its: property, restaurant, pro shop, rates, course condition, playability, operations, hours, product offerings, available tee times, range operations, available carts, available play, tournament hosting, special events, number of holes available to play, authorized instructors, terms and conditions, benefits or, in its broadest form or

interpretation, any other aspect of its business operations; adherence or adjustments to accommodate: governmental requirements, national emergencies, governmental health edicts; needs of PSGC; or for any other need or reason it solely deems necessary.

No-Show And Tee Time Booking Policy: I understand and agree to that the PSGC no-show tee time policy applies. Due to high demand, limited tee times and lost revenue if I do not show for my tee time, PSGC has implemented its standard no-show policy for Memberships. I may make tee times for future play for myself and for anyone else in my party by paying the current rate for that tee time for those in my party, if I do not show up for play or cancel within 48-hours of the scheduled time understand and agree that I will be billed and pay for the then current round rate for myself, additionally I understand that there is no refund for the other players. I further agree to provide PSGC with a credit or debit card to be maintained in the POS system, as defined in the Credit Card On File Agreement, and authorize PSGC to charge my credit or debit card on file for the no-show(s). Members may book up to 7-days out, the member may book guests along with the member's tee time, since PSGC is on a pre-book/pre-pay system the guests must be paid at the time of booking. PSGC does not hold tee times without prior payment and bookings are non-refundable.

Cart Fee Charge: Cart Fee is automatically charged for Single Walking members if you book online or in Pro Shop, If you prefer to walk then call the Pro Shop to book your round and let them know you do not need a cart. If you choose to use a cart during your round you will be charged the \$25 Cart Fee, the charge will be charged to: your on file credit or debit card (must sign the PSGC, LLC Individual Or Business Credit Or Debit Card On File Agreement), or by payment you provide us in person or by other means.

Additionally, you understand and agree that this membership: is limited to access of PSGC property for the sole purpose of playing golf during the hours designated by PSGC and only if you have booked a tee time via the online system or through the Pro Shop (you must check in with the Pro Shop to access the property and play golf); represents the entire agreement between you and PSGC; supersedes any other PSGC agreement, is only valid if in writing, signed by you and PSGC and you have paid the appropriate fee defined herein. Agreement may be approved or denied for any reason, at the sole discretion of PSGC.
